**3. ITEMS FOR DISCUSSION**

- A. Discussion of Park Equipment: Status/condition of City-owned/acquired equipment essential to the day-to-day operation/maintenance of Oakdale park to include, but not limited to, vehicles, grounds maintenance equipment, pool equipment, laundry/housekeeping equipment, large appliances, etc. Essentially large or high-value equipment items, especially those items that are either in need of replacement or major repair.
- B. Discussion of Park Maintenance: Identification of maintenance needs/status identified in the 2016 "Oakdale Park Pool Report" and "Oakdale Park, Glen Rose, Texas Safety/Building Inspection" reports produced by City of Glen Rose, Oakdale Park Manager and City of Glen Rose Code Enforcement Officer/Building Official, respectively, to include maintenance needs that have already been resolved, and any additional facilities maintenance issues that have been noted since production of these reports.

- C. Discussion of Park Policies: Identification and content discussion regarding park specific policies that need to be revised, clarified, or established in the following areas: a) Guest/Visitor Policies, b) Employee Policies, and c) Contracted Work Policies with the goal of developing policies in these areas to be presented to Council, at a later date, for final discussion and approval.
- D. Discussion of Oakdale Park Fee Schedule: Discussion regarding establishment of a standardized, consistent fee schedule with the goal of developing a reasonable/competitive fee schedule to be presented to Council, at a later date, for final discussion and approval.
- E. Discussion regarding the future direction of Oakdale Park as a “venue” for events.
